Aquatics Class, 2026 Participant Agreement and Liability Waiver

This agreement is by and between **MS Bright Spots of Hope ("MSBSH")** and the adult participating in any and all Aquatics classes during 2026 (hereinafter referred to as the **"Participant."**)

The Participant certifies that they have had the opportunity to review the contents of this agreement, fully understand its terms, and consent to them by registering for the program of their own free will.

Participant Responsibilities

The Participant understands that an MS Bright Spots of Hope Aquatics class includes approximately **45–60 minutes** of fitness activities. All classes are taught by certified instructors at the **Renaud Center**.

The Participant acknowledges that they assume all risks associated with participating in the class and understands that MS Bright Spots of Hope does not assume responsibility for providing financial or other assistance in the event of injury.

The Participant acknowledges that MS Bright Spots of Hope does **not** carry accident or medical insurance for class participants and agrees that their own insurance shall be used to cover any medical expenses.

The Participant further understands that they may be responsible for any medical expenses not covered by their insurance. If the Participant does not have medical insurance coverage, they agree to be solely responsible for payment of any medical bills resulting from injuries incurred while participating in MS Bright Spots of Hope classes.

Release of Liability

The Participant hereby releases and discharges **MS Bright Spots of Hope**, including its Officers and Board of Directors, from any and all liability for claims involving bodily injury, personal injury, illness, death, or property damage that may result from participation in MS Bright Spots of Hope activities, whether caused by the negligence of MS Bright Spots of Hope or its employees.
